OFFICIALS: The officials for the above event shall be qualified persons satisfactory to Ohio Swimming, Inc., and if requested, a list of such officials will be submitted to the Sanctioning and Scheduling Committee Chairman within 10 days of the request or one week before the event, whichever is later. The Meet Director, Referee and ALL deck officials shall be members of USA Swimming.

CONDITIONS AND REPRESENTATIONS: As a condition of obtaining the sanction herein applied for, I and the above named meet sponsor, whom I represent, agree to pay such sanction fees and/or service charges as determined by Ohio Swimming, Inc., and we further agree to abide and govern this event under the rules and regulations of USA Swimming, Inc. and Ohio Swimming, Inc. And all other terms and conditions upon which this sanction may be granted, including specifically all local rules and regulations and those set forth in the current edition of the USA Swimming Code, and the OSI Swimming Handbook.

Particular attention is directed to the USA Swimming Code which provides that no further sanction will be given to any organization which has failed to fulfill expense obligations to athletes or to award prizes as stated on its entry blank until the obligations are satisfied or the prizes awarded.

In granting this sanction, it is understood and agreed that USA Swimming, Inc. and Ohio Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event. See USA Swimming, Inc. Rules & Regulations.

SANCTION FEE: A sanction fee of \$10.00 is required with this application. This is required for all sanctioned events including time trials or dual meets where no entry fee is to be charged.
